Hi all,

I think I made an error as I assumed that, when I said that Mr. Ike's findings help prove the case genuine, I forgot to walk him through the obvious **THINKING** process that I used, which included the following.

Since Mr. Ike took, if I recall correctly, several days of research in a modern library, and used state of the art computer technology to do online searches, it seemed obvious to me that this process was in itself contributing to validating Meier's account of things. Let's go a bit further.

This, of course, begs motive and also suggests prescience concerning events that would be foreseen at that time to have special and controversial significance later in

the future. Wow!

I guess Semjase was also in on that conspiracy because she tells Meier to not publish the predictions until February of 1980, thereby validating in advance the clever conspiracy presumed by Ike, i.e. the whole situation around Stevens discovering he has information that is not meant for public consumption until approximately one year later.

Gee, why weren't Meier, Stevens, Vogel, Pelozzi, Norton and Semjase either working for intelligence services or writing best-selling espionage thrillers?

So, it sounds like the information wasn't widely disseminated until after the events occurred.... A competent magician or anyone with more than two friends could duplicate that feat without any help from ETs.

As you can see, I am unable to confirm to my satisfaction that Meier has successfully predicted anything.

I am interested in references to any documented facts on the subject. I would prefer not to argue about different interpretations of gray areas (such as whether Metis and Adrastea are big enough to be considered moons of Jupiter, or whether the personal testimony of Marcel Vogel or Wendelle Stevens is believable). If the case is genuine, surely there are some clear-cut facts out there somewhere.
