Dear Vaughn,

In the context of the overall situation you accepted my challenge to duplicate Meier's photos and films (where are they?), which you called an "easily duplicated hoax". The point was to duplicate the photos and films, not the "effect" as CFI-West attempted to claim. Duplicating the photos would require that the unique characteristics, revealed under specific and credible scientific examination of the Meier photos, be duplicated to support the hoax theory.
